





# Spear becomes 93rd Potentate of Mahi

Noble Dale Spear, the popular and active Shrinemason who has served in so many capacities has reached the top of the Elected Divan line as Potentate of Mahi Shriners.

Dale A. Spear was born on August 2, 1971 in Miami, Florida to Dale and Wilma Spear. He grew up in the Westwood Lakes area where he attended local schools and graduated from Southwest Miami High in 1989. He attended the University of Miami and then Florida International University where he graduated with a double major in Marketing and Business Management. Dale's mechanical knowledge and troubleshooting abilities led him to become a technician with the Miami Dade Public School System where he quickly became noticed as a valuable asset to the organization. He then moved on to become an Area Supervisor with Broward County Schools Facilities Management, a position he holds until today. He is responsible for all schools south of Interstate 595. This job is challenging in as much as the functionality of a school relies solely on its physical condition, mechanical working order and safety level all of which must be maintained at optimum levels. Dale has to frequently deal with crises that involve keeping a school open to serve and protect its students. The recent school shooting at Marjory Stoneman Douglas High School in Parkland is an example. Dale will soon have to oversee new and creative security measures on each of his campuses to enhance student safety.

While working for Miami-Dade
Dale met the late Noble John R. Barton
and the two became fast friends. John
was a prominent Mason and Dale soon
was asking how he could become a
member of the fraternity. He was initiated into Coral Gables Lodge and was
raised a Master Mason in 1998. He immediately became an officer and served
as Worshipful Master in 2004. He had a
very successful year and impressed the
members as a capable and benevolent
leader. The lodge under his tenure was
a place of good ritual work and fun.
Dale then took the office of Treasurer,

a position in which he served until 2017. He moved on from the lodge and held several key positions in the Grand Lodge Committees serving as Zone and State Chairman for many years. He is best known as "the guy with the ties" from his years as chairman of the Fraternal Administrative Endowment Fund or FA 100 which facilitates contributions by selling a neck tie designed by the Grand Master each year. He served as the District Deputy Grand Master of the 27th (35th) Masonic District in 2007-08 under Most Worshipful Robert Harry and was recognized as one of the most successful leaders of that year. Dale also joined the Valley of Miami Scottish Rite where he is a member of the 30th and 32nd Degree Casts and Mi-Am-I Grotto M.O.V.P.E.R. where he served as Monarch in 2011. He is currently a Supreme Council District Deputy for the Grottoes of North America. He served as the Chairman of the Masters' & Wardens' Association of Miami-Dade County in 2013.

Dale was created a Noble of Mahi Shriners in June of 2005 after intense lobbying from Illustrious Sir Edward Light P.P. to join the order. It was a good decision as he been extremely active since that time. He has served as Potentate's Aide, Masonic Liaison, Ceremonial Master and many other key positions within the order. He became a regular at the Director's Staff and participated in many parades. Many of Dale's closest friends within the fraternity recognized his likability and strong leadership qualities and urged him to seek an elective office. He finally agreed and was elected Oriental Guide in 2015. However, after the resignation of the High Priest and Prophet that year, he was elevated to that office in a special election in June. On December 14, 2017 he was elected as the 93rd Potentate of Mahi Shriners and was installed on January 8, 2018.

In 1998 Dale met Mitzie Pye and they began dating. He wondered how he was going explain to her what this thing called Masonry was and why it took up so much of his time. Luckily, she needed no explanation since her father was a mason, her mother and sister were in the Eastern Star, and she herself had been a Rainbow Girl. The young couple fell in love and married on April 27, 2002. They live in Plantation and have two four legged kids (Boston Terriers) named Happy and Tubby, who are now officially the First Dogs of Mahi.

Outside of Masonry Dale is an avid sportsman. His hobbies and interests include fishing, diving, golf, motorcycles (Harley Fat Boy), traveling, and Corvettes. In fact one of his most prized possessions is his 2013 Sixtieth Anniversary Corvette, a vehicle that he sought for many years. Lobster season, mini and regular, finds him diving for the delectable shellfish and he always brings home his limit. On land he is an avid NASCAR and American La-Mans Fan and travels to many races throughout the year. The hobby that brings him the most places is skiing. Dale has a rule to ski someplace different every year. He has tackled the slopes at Killington, Vermont; Heaveny & Sierra, Lake Tahoe; Jackson Hole, Wyoming; Park City & Canyons & Deer Valley, Utah; North Carolina; The Catskills; The Poconos; and Massnutten, Virginia.

Although Dale fully embraces the importance of membership and fiscal responsibility, his main focus is to promote unity within Mahi, a goal he hopes to readily achieve in 2018.



# 1928 Imperial Shrine Session helped put City of Miami back on the map

# Remembering one of Shrinedom's greatest spectacles 90 years later

In September of 1926, a powerful category 4 hurricane roared across South Florida leaving a path of destruction from Homestead to Palm Beach. Hardest hit was the young and vibrant City of Miami where the eye of the storm had passed directly overhead. Looking back on the damage that occurred, there is a haunting resemblance to that of Hurricane Andrew some 66 years later. The City was devastated both physically and economically. Newspapers around the nation carried the headlines, "Miami wiped out"! To the residents and businesses it would seem that Miami really was wiped out. The preceding years had been filled with explosive growth which established the city as a top tourist destination as well as an ideal place to live. These were the so called "boom years" and Miami was known as the "Magic City". However as early as 1925, the bubble started to burst. Building supplies were hard to come by and the railroad and cargo ships could not keep up with the demand. Shady land deals that involved fictitious property were beginning to be exposed and defaults on loans increased steadily. When the storm struck on September 18, 1926, it brought the Great Depression to South Florida a full three years earlier than the rest of the U.S. It was time for the community to band together and rebuild. Proudly, Mahi Temple was at the forefront of this effort.

Over 50,000 Shriners and public spectators alike filled the bleachers on Biscayne Boulevard in Downtown Miami on Tuesday May 1, 1928 for the Imperial Council Session's Day Parade. Mahi Temple had built an entire Arabian like village in and around the one year old Bayfront Park for the visiting Nobility as well as an extremely elaborate Parade Grandstand for the Imperial Officers and City Officials. At left, the Miami Daily News reports on the festivities earlier that day.

Mahi had been established in 1922 to serve the growing need of Miami's Masonic brotherhood who desired to cross the hot sands of the Shrine. By 1926, most of the influential businessmen and municipal officials in the area claimed membership in the growing Shrine Chapter. In the aftermath of the storm it was that leadership within the fraternity that spearheaded relief and rebuilding efforts. However, there was more to be rebuilt than homes and businesses; something of far greater importance. That something was Miami's damaged economy.


A plan had to be formulated to let the nation know that Miami was still here and was better than ever as a place to visit or even settle down. It was perhaps sometime in the spring of '27 that the leaders of Mahi decided that the best way to rebuild America's confidence in the city was to invite their brother Shriners down for a visit. The Temple would seek to host the 1928 Imperial Council Session which would bring tens of thousands of Nobles of the Mystic Shrine to Miami, most of who were the nation's movers, shakers and pillars of the community.

The task at hand was no easy situation. Putting on a convention of this size would require a huge volunteer workforce, cooperation from local merchants and businesses and most importantly, money. Lots of money. However, anyone who doubted that it could be done was sorely mistaken. As mentioned, Mahi was populated by some of the biggest names in town who could make big things happen. By the time the delegation left to make its pitch in Atlantic City in May of 1927, close to \$200,000 had been raised as seed money, mostly from the cities of Miami, Miami Beach, Coral Gables and Dade County. The Imperial Council, however, was hesitant to agree to the proposal, but the impressive and well thought out proposition presented by Mahi was enough to persuade the delegates to award the convention to Miami. The planners would have less than a year to put together what they thought could be the greatest spectacle ever held by the fraternity.


Thus the work began. Committees were formed, hotel rooms were secured, donations from businesses were sought and countless plans were created, rethought and created again. Every aspect of this event had to be spectacular in nature if the goal of reestablishing Miami was to be achieved. The first order of business was to come up with a marketing scheme and logo. A contest was held amongst the Nobility to come up with a catchy slogan to entice Shriners to attend the elaborate event. -->


Mahi built the Bayfront Park Bandshell for concerts during the session and then turned it over to the city. It was razed in 1947 and was replaced in 1950.



24 Pharaohs held court in Bayfront Park. Note the Colonial Hotel and Miami News (Freedom) Tower in the background.


The winning slogan ended up being; "Come on Fez, Miami Sez!" This campaign would be seen in countless newspapers and magazines that winter. Locally, Mahi envisioned creating an Arabian Village or "Garden of Allah" in Bayfront Park where parades, stage shows and exhibitions could be held. The convention delegates had to be convinced that Miami was a place of fantasy and mystique.

By February of 1928 work had begun on this mammoth project. Two pillars adorned by Arabic mystical figures were erected at N.E. 3rd Street and Biscayne Boulevard and marked the entrance to the village. An extravagant grandstand was built at N.E. 1st Street to house the Imperial Potentate and Officers when reviewing parades and other street entertainment. Across from this were enough bleachers to hold 20,000 spectators. Around the corner and down Flagler Street, each Temple of the Order was represented by a large fez, inscribed with its name, placed on top of streetlamps. The Olympia Theatre, in this vicinity, was to be the headquarters for the business sessions. Delegates would be housed in the numerous large downtown hotels such as the Everglades, McAllister and Columbus. When those rooms were filled, the Nobles would be housed in private homes, apartments, Pullman rail cars or on passenger steamers docked at the nearby Municipal Docks. Also at those docks, arrangements were made to have two U.S. Navy Destroyers and two submarines available which would serve as an additional attraction by being open for tours. More importantly, this would also allow hundreds of sailors to get shore leave and spend money in the city at the same time. Preparations were also undertaken within the surrounding community. Arrangements were made at venues of all sorts throughout Dade and Broward Counties to host parties and banquets. This tactic was used to enable delegates to get away from the business district and see what the surrounding suburbs were like; those suburbs which might entice them to relocate to the area. To assure a pleasing presentation, any area of the city considered to be plagued by blight was cleaned up. Any unsightly roadside junk or debris were carted off. Dense underbrush and landscaping were tended to and any displeasing trees or shrubs were removed. The County even gave trees away

to any homeowner who would plant it in their front yard. Across the bay, Miami Beach was bustling and events were planned for the many bathing casinos . Even the telephone poles on the County (MacArthur) Causeway were decorated with colored canvas cutouts of butterflies. Local dealers donated luxury "open" type for the use of important delegates. Buses and limousines were hired to transport delegates to various hotels and points of interest. There would be no The two biggest supporters of the reason for anyone not to travel around.



event; Honorable E. G. Sewell, Mayor of Miami and Ill. E.B. Donnell, Potentate of Mahi for 1928.

And so the stage was set.

The 25,000 attendees began arriving and the session officially began on May 1. For the next three days, Miami was transformed into one big party, a party which the city had never seen before. Days were filled with competitions, parades and street shows. Nights were filled with galas, banquets, dances and more parties. Nighttime brought the most spectacular events. Transparent canvas was strung along the roof line of the Royal Palm Hotel and lit from behind with spotlights. Ballerina dancers would then perform in front of the lights, creating a silhouette effect on the canvas that was quite the sight from the ground. A lighted boat parade was held in the bay, much like today's Winterfest Boat Parade. However the crowd favorite each night was a new device called the "aurora" light which was a bright spotlight and a revolving beacon with different color shades were used to send out beams of light onto the sides of downtown buildings. For 1928, this was hi-tech.

Needless to say, the convention was a huge success. Delegates sent letters to Mahi thanking them for the wonderful time claiming that they had never seen such a beautiful city or been treated so well. As for the city, the seed of recovery had been planted and began to grow. The event was soon followed by the national Elks and Lions Conventions later that year. Tourism began to flourish again and by the early 1930's, South Florida was back on the map and less impacted by the Depression than the rest of the nation. As for Mahi, the event ended costing \$2000 (about \$30k in 2018) but it was agreed that this was a small price to pay to help the city. Mahi would host 3 more Imperials in 1952, 1961 and in 1971, still considered the largest convention ever held in Miami-Dade.

Whether or not the Imperial Session saved the city is up to interpretation. The area would of surely bounced back eventually, had the event not been held. However, the Nobles of Mahi can be proud that their organization took charge in the community and did its best to help accelerate the recovery by holding one of the most spectacular events in the city's history.



# A LOOK BACK INTO MAHI'S HISTORY



Mahi has always been very community minded. The nobility has always participated in fundraising and activities outside that of our fraternity and Shriners Hospital for Children. One such example was the sponsorship of a local amateur baseball team that played in the early 1940's. The "Shrine" team played in a community league at Miami Field, a small baseball park located at the southwest corner of the Roddey Burdine Stadium (Orange Bowl) complex. prior to the construction of the Miami Baseball Stadium (Bobby Maduro Stadium). Any professional or community baseball was played here, including that of the University of Miami teams. The outfield was actually the southwest corner of the football stadium. Seen above is Shrine team in the spring of 1943. The coach, Illustrious Sir Raymond Williams (2nd row, third from right) and manager, Illustrious Sir Robin Mulloy (front row, first on right) were two future Potentates. It is unclear how many years the team played and no other information survives beyond the photo.



Many years ago it was not uncommon for local politicians to belong to Mahi. Such was the case when Noble Daniel T. McCartney was inaugurated as Governor of Florida in 1953.

McCarty was a cattle farmer from Ft. Pierce (once a part of Mahi's jurisdiction) and served as a state representative from the area. He was sworn in on January 8, 1953. McCarty suffered a debilitating heart attack a month later and had to govern from his bed until he developed pneumonia and passed away on September 28, 1953.



Everyone knows that South Florida is one of the major boating capitals of the United States. Therefore, whatever organization one belongs to, there are sure to boaters and fisherman within the membership. Mahi has been no exception through the years and units such as the Mahi Fleet, Mahi Mariners, Royal Pirates and International Association of Shrine Yacht Clubs have been prevalent. Seen above is the first group of these boaters to organize, the Mahi Fleet. On March 30, 1963 the fleet departed from the Seminole Docks on the Miami River and motored down to Elliot Key County Park (Biscayne National Park would not be formed until 1974) where they enjoyed a picnic and swimming. The unit lasted a few more years and evolved into the Mahi Mariners in 1966.



Mahi's jurisdiction once stretched north to Indian River County. There were once many shrine clubs such as West Palm Beach, Martin County, Ft. Pierce and Vero Beach. In March of 1972 the Jupiter Shrine Club in northern Palm Beach County was given a dispensation and worked hard for nine months to prove themselves. The result is seen above as Illustrious Sir Jay Kraeer presents club president Joe McKenna with the charter on January 17, 1973. The club would become part of Amara Shriners when that temple was chartered in June 1974.





# Miami Shrine Club to begin meeting again



# MASONIC NEWS



## What do you know about the Masonic Home?

The Masonic Home of Florida is situated on 18 acres of lush landscaping on the shores of Coffee Pot Bayou, a picturesque inlet off Old Tampa Bay is surrounded by the finest neighborhoods in the area and close to major shopping centers and dining in Downtown St. Petersburg.

This choice waterfront location has been owned and operated by the Grand Lodge of Florida since the early 1900's and shares a century old tradition with the City of St. Petersburg. The Home was originally set aside for children slowly turning over to the needs of senior Masons and their wives/widows as aging demographics changed. A series of building expansions beginning in 1973 brought us to the present 150,000 square foot Home which can accommodate up to 187 Residents in a state-of-the-art setting. There are gracious lobbies, an elegant dining room overlooking the grounds and water, a 5,000 volume library, billiards and activities rooms, gift shop, community kitchenettes and lounges, a chapel, waterside pavilion and fishing pier plus a host of other amenities which make the Masonic Home one of the premiere facilities of its kind in Pinellas County. Recently, the City of St. Petersburg presented The Masonic Home a Mayor's First Place Award for Building and Grounds Beautification.

Lifecare Plan: This traditional plan is available to any Master Mason who becomes a member of a Florida Lodge prior to the age of 70. He must be a member in good standing of a Florida Lodge for at least ten years and continually for the last three. The wife or widow of a Master Mason is eligible for residency based on his membership. Contact your Lodge or the Masonic Home for an application. Upon completion, the application is signed by the Worshipful Master and Secretary. It is then presented to the District Deputy Grand Master for review. The application is then forwarded to the Admissions Committee, Board of Trustees and Grand Master for final approval. This process takes approximately 30-60 days. Dual members are





also eligible. Under the Lifecare Plan, assets owned by the Resident such as property, bank accounts, stocks, social security, pensions, etc., are deposited with the Masonic Home. These assets are then converted to cash to establish a Resident Maintenance account. Each month, this account is debited to cover the cost of care. Residents retain 10% of any liquid assets, initially and subsequently, in excess of \$10,000 for personal use. When assets are exhausted, the Masonic Home continues to provide care throughout the lifetime of the Resident regardless of his/her ability to pay.

Pay As You go (Private Pay): In May 2005, the Grand Lodge of Florida approved Private Pay admissions for Florida and non-Florida Masons. This plan provides an opportunity for Florida and non-Florida Master Masons and their wives, widows, mothers, fathers, or ladies of the Order of Eastern Star to retain control of their assets while enjoying all the Masonic Home has to offer. Residents pay a three month deposit and \$3,650\* monthly for Assisted Living and \$6,083\* monthly for Skilled Nursing care. Most fees and services are included except medication. For couples entering the Masonic Home, the first person pays this monthly fee and the second person fee is \$1800\* monthly. Applicants for Pay As You Go should get in touch with the Masonic Home directly to begin the admission process which can take as little as one week for approval. \* Rates subject to change.







# So Much for Conspiracies: Israeli Freemasons Function as 'Boy Scouts for Adults'

With its history shrouded in mystery and its existence being the subject of countless conspiracy theories and myths, the Freemasons operate openly in Israel and eagerly accept new members, according to one of the organization's lodge presidents.

Instead of being a secret society bent on world domination, Freemasons are a group that openly advertises its presence and strives to promote morality and integrity, Roy G. Guttmann, a lawyer and the president of Lodge Muffelmann Oman 29, told Haaretz.

"When I'm asked what Freemasonry is, I reply that it's Scouts for adults," Guttmann said. He further sought to debunk rumors about Freemasonry being some kind of cult. "There is no one figure here that people worship or to whom they donate. It's not a belief in a particular religion," Guttmann stated, adding that the organization accepts "brothers from the monotheistic religions." The freemason added that the society "consists of an older public" and therefore seeks to make it "more youthful" via new admissions, warning however that 'being a Mason is a way of life of morality, integrity, help and truth."

He noted that while the application process itself is fairly easy, with prospective candidates able to apply for membership via website or an email to the Grand Lodge, though "not everyone is accepted."

According to Haaretz, there are currently 50 masonic lodges in Israel subordinate to the Grand Lodge, with a total membership of about 1,200 brothers.
